George and Danielle Reyna, Chehalis – Expressed his concern about the ongoing issues with his neighbors and within the city. He's very frustrated with his situation and has put his house up for sale. He's been going through this for over two years and is fed up with it. He has a no contact order against these people and is not sure why the police aren't doing anything about it. The most recent issue was that is tires were slashed. These people are now jumping his fence with a knife in their hand. He feels that his hands are tied, and he can't get help from anyone. He's worried that this is going to explode and fears somebody getting seriously hurt or killed. Chief Brockmueller empathized with them and explained that the officers do show up to calls and respond as they can. All charges have been referred to the prosecutor. Councilor Heather Stewart asked about the legal obligation for the city to respond. The city clerk responded that there is a 5-day response. Councilor Stewart asked, what is the repercussion of the no contact order if someone breaks it? Chief responded that they could refer, arrest, or write a ticket. Chief also stated that everything that comes from there is at least referred.

Tim White, Small Acts of Kindness – Is excited about the event! Had a few issues getting the event insurance but worked it all out. Tim provided the city clerk proof of insurance, Certificate of Liability Insurance and Special Occasion License from Washington State Liquor and Cannabis Board, License No. 090032.

NAPAVINE COUNCIL MEMBERS PRESENT:

Mayor Shawn O'Neill, Councilor #1 Brian Watson, Councilor #2 Larry Stafford, Councilor #3 Don Webster, Councilor #4 Heather Stewart, and Councilor #5 Duane Crouse.

TOLEDO COUNCIL MEMBERS & STAFF PRESENT:

Mayor Dobosh, Councilor #2 Eric Hayes, Councilor #3 Shelly Thomas, Councilor #4 Kathy Hill, City Clerk Deavon Jacobson, Police Chief Sam Patrick,

<u>CITY STAFF MEMBERS PRESENT:</u> City Clerk Rachelle Denham, Treasurer Michelle Whitten, Bryan Morris PW/Comm Dev Director, Police Chief John Brockmueller.

ROUND TABLE DISCUSSION: Potential Napavine and Toledo Interlocal Policing

Key Points: Term of Contract, Presence of officers in the cities, Vehicles/Equipment, and Court Services.

Discussions took place between all parties regarding the potential of combining Napavine and Toledo police departments. Currently Napavine is looking to work up a contract that would expire 12/31/2022 this is due to budgetary processes.

- *Mayor Dobosh: Is in support of the interlocal policing. In the past Toledo had done this with Winlock and it worked well. There was a savings for both cities. He would like a three-year contract but is fine with the six-month to see how everything works out.
- *Eric Hayes: Is in support of the interlocal policing. His points were based around the term of contract, police coverage and the PD/Clerk position.
- *Kathy Hill: Is in support of the interlocal policing. Toledo is not as large for coverage area but could make resources go further. Would like more discussion/information for the PD clerking for courts.
- *Shelly Thomas: Is in support so far/ on the fence of the local interlocal policing. Perception of patrol in the city, what it will look like.
- *Mayor Pro Tem Crouse: Is in support of the interlocal policing. Having 24-hour coverage is huge.
- *Sheriff Snaza: Expressed his support for this interlocal agreement between the two cities. He's worked with other local cities along with Alan Unzelman and it's been a positive experience. Things to consider are jail fees, and dispatch fees. Currently Toledo utilizes district court. Sheriff Snaza feels that it would be beneficial to switch to municipal court. If this agreement was to not work out and the sheriff office was to respond it would only be for active calls only.

- *Heather Stewart: Is in support of the interlocal policing. Asked what the 24-hr. coverage will look like. Chief Brockmueller stated that one officer in a patrol car at all times. She is interested to see more solid facts and numbers.
- *Jim Buzzard: Shared the difference between District vs. Municipal Courts. The district court judge is elected. This often provides a disconnect from the citizens in the community. Whereas municipal judges are more in tune to the community they serve. Has some data that he will provide us that show the numbers for district
- *Don Webster: Is in support of the interlocal policing. If it can be worked out let's do it!
- *Larry Stafford: Is in support of the interlocal policing.
- *Brian Watson: Is in support of the interlocal policing. Concern at this point of having six officers for two towns and how the coverage will be. Would like to know how the schedule will work and doesn't want to take away from Napavine.

In closing, Jim Buzzard stated he is in favor of a six-month contract until the end of the year. Then it can be extended after that point. Mayor O'Neill asked for dates/times to setup another workshop to go over specifics to include cost, and coverage. Rachelle will reach out to Deavon and get the next meeting scheduled.
