



RE: Clerk's Report for Council Meeting, January 10, 2023, Happy New Year!!!

***** December Billing Update:

- City billed out a total of \$221,384.93 in water and sewer bills.
- Total of 90 accounts were charged a delinquency notice with a total of \$2,090.86 in late fees.

End of Year Update

- City Billed out a grand total of \$1,348,754.18 in water and sewer bills.
- City Receipted in a grand total of \$1,347,214.06 in utility bills.
- Total of 101 accounts hold a balance of \$0.01 or greater, equaling a grand total of \$25,282.82 in arrears.
- City currently has 2 properties which have water and sewer liens in place.
- One account is still participating in the COVID-19 Contracted Payment Plan which owes \$76.15, which will be completely paid off in February 2023.
- Total of 165 Badger Meters are in the ground and 16 customers are signed up with the EyeOnWater app!
- Council Tablets: The tablets are all setup and will be usable at the 01/10 council meeting. All council members will need to read and complete the City Council & Mayor Computer Policy prior to checking the tablets out. It's totally up to you if you want to check your tablet out or keep it here at the city hall.
- Elected Officials Liability Workshop: This workshop for City Council and Planning Commission members is scheduled for Thursday, January 26th at 5:30pm-7pm. All of you should have received the calendar invite I sent out mid-December.

- Council Chamber Renovation: The time has come to make some improved changes! Beginning end of January, the dismantling and rebuilding will start. The carpet is tentatively planned to be installed early mid-February. The judge stand will be lowered to mirror the area where council currently sits during council meetings and new carpet will be installed. The next phase will be our sound equipment. Items were ordered mid-2022 and due to supply and demand issues it's taking a very long time to receive equipment.
- Planning Commission Meeting Minutes: Would you like to see the minutes in your council packets? My thought is the minutes can be easily accessed on the website. Since the launch of the new website everything is very simple to find. I will do whatever works best for all of you just let me know.
