CALL TO ORDER:

Klumper Woodard Project: 6:06 pm

Director Morris explained that they have 17 duplexes on 10,000 sq. ft. that will not be subdivided and it will be a planned unit development.

- Safe Walking Route to school Discussion was route should be lighted, and if the 60 homes across goes in they may be able to get access to the school via a walking path. Would become an easement so both developments could use it.
- 2. Street Lights Discussion was had and conclusion was set up 200 ft. intervals and see where it lands to see how many lights would be required.
- Private Community or Dedicated road for utilities. Discussion was had and decided that it would be on the developer on what they choose. If private community, sidewalks wouldn't be required inside development.
- 4. Mail Kiosk or PO Box Discussion was had and Kiosk would be the best.

Jefferson Street Mini Storage: 6:39 pm

Director Morris states this is proposed 25' x 80' Mini Storage unit with an office space.

- Frontage Improvements Theme in surrounding area right now is slab on grade, paved to the buildings. It will be all asphalt, benefit to surrounding businesses. May need ADA parking spot, depending if employees.
- 2. Commissioner Torgerson asked if security fence will be installed. Arnold Haberstroh stated yes, chain link fence will be installed, also security lights, south end vapor light. No street lights required.
- 3. Already has existing utility hook-ups for office.
