Administrative Assistant Katie Williams stated developer has .96 acres that currently has 2 houses on it, would like to short plat property to make the current 2 houses have their own 7500 sq. ft. lots and subdivide the remaining property into (2) 7500 sq. ft. lots for single family dwellings and (1) 10,000 sq. ft. duplex lot. New lots will front Railroad Avenue, theme of the neighborhood is no sidewalks, curbs or gutters. Developer is willing to put in 1 street light at duplex. Safe route to school is the pedestrian overpass, roughly 300 ft. on Third Avenue. Discussion was had and Planning Commission decided as long as it meets city standards, street light and hydrant would be the only requirement due to the theme of the neighborhood.
