CALL TO ORDER: Commission Chair Hamilton called regular planning commission meeting to order at 6:00 pm.

ROLL CALL:

APPROVAL OF AGENDA – As presented:

Junk Vehicle Discussion

Commissioner Bozarth invited Chief Salyers to discuss with the Planning Commission regarding Junk Vehicles and ordinances. Discussion was had and the conclusion was Chief Salyers is still working on that situation on W. Washington.

Water Bill Deposits

Commissioner Haberstroh wants to know why the City stopped collecting water deposits for tenants signing up for water services? And if the City can start requiring deposits for services again? Discussion was had and Director Morris said he would look into it and provide feedback at the next meeting.

GOOD OF THE ORDER:

Commissioner Bozarth stated that everyone should look at what the City of Mossyrock is doing right now, and would love to see Napavine follow suit. Commissioner Bozarth asked Chief Salyers his opinion. Chief Salyers says he has no opinion in this matter, and if someone asked him, he would suggest at this time is to wait and see what happens and go from there. Director Morris stated he will not sign the Christmas Parade permit because of COVID
