Requested to defer utilities from west of driveway entrance to property line, roughly 240 ft, until or when property to the west would get developed. Discussion was had and will research bonds, legal agreements for deferring, 5-year timeline, but it may be cheaper to just extend the utilities when construction was happening, versus later on.

# **CITIZEN'S COMMENT:**

William Ayers discussed about getting the blessing of Planning Commission to divide 44 acres into 1.09 acres and put wells and septics on the Woodard Road project. Director Morris advised Mr. Ayers that the city would possibly require an agreement with steep stipulations. Commissioner Bozarth asked Mr. Ayers if he had a site plan, or could possibly provide one to get a picture of what he is looking at doing. Mr. Ayers said he would try to get one and submit it prior to the next meeting.
